NALSAR Forums • NALSAR Forums [<https://nalsar.ac.in/forums/>] is a website which is currently being used by both the B.A.LL.B (Hons.) and the LLM batches for accessing the recordings of the classes, course materials, as well as for any discussion with professors and students, both academic and otherwise. Forums currently has 990 registered users, and more than 5000 media files, which includes classes, course materials as well as discussions on topics as diverse as philosophy and Maggi recipes.

• NALSAR Forums is built to bridge the gap between the teachers and the students, both in terms of communications and discussion, in an attempt to make up for the lack of physical interaction due to the online mode of education.

• The Forums has various features which helps reach its objective, such as multiple file uploading, threaded replies, private messaging, user notifications, email communications when subscribed, as well as dedicated Forums for the various Committees under the Student Bar Council for announcements and other Committee related materials. Forums has also been used by Committees for discussions with students surrounding policy consultations which were hosted by the Committees.

Academic Information System (AIS) • AIS Nalsar is an inhouse integrated LMS and placement support system intended to offer enhanced student learning and effective academic



management. The system is being currently used by the Department of Management Studies at NALSAR. • AIS has multiple login pages that define the properties of the users like student login, Coach login, Institute login, Placement Officer login and Employer login. Feedback Obtained
<p>Keeping channels of communication open was critical in order to undertake empathetic administration during the pandemic. The semester schedule, the examination scheme and other resource support was organized and provided by the University by obtaining feedback from all stakeholders, students, faculty, administration and parents. Keeping in view the uncertainties of the times, the University opted for weekly tests to keep evaluation continuous but not burdensome. Recognizing the fact that all students did not have equal access to the internet, all classes were recorded on pen drives and posted to the students with access difficulties. Laptops were procured and sent to students who were in need of them. Even as NALSAR faculty in the main settled into the online mode of education relatively easily, since we did recognise one size does not fit all, faculty were permitted to use the procedure in which they felt they were most effective be it live classes or recorded lectures. As several students and faculty experienced mental distress, the university arranged for virtual counseling. Several parents spoke of economic hardship and consequently the fee payment deadlines were relaxed and fee waivers and rebates were also provided. The university tried its utmost to operate as a caring space and tried to do its utmost to respond to the needs of the surrounding community be it the people in Shamirpet or the transiting migrant workers.</p>

### 2.3.2 – Students mentoring system available in the institution? Give details. (maximum 500 words)

As noted in the reports of previous years, the University has put into place the Teaching Assistance (TA) Programme, where students who are currently in their final year, or LL.M. students conduct tutorial sessions for the students in the first three years. These tutorials supplement the class learnings, and are divided into smaller groups of not more than 16 students to facilitate discussion, and help individualised assistance to the students. This programme is monitored by the respective teachers, and credits are provided to the TAs. In addition to this, the University also provides a session on Research and Writing for the freshers' batch to acquaint them with the basics of research, regarding the resources available, and writing skills, which can be learnt through projects. The students are also encouraged to approach the faculty for help regarding projects and other research areas. In addition to this, two student committees also work on providing support to the freshers of the University. The SBC Academic Committee and the Social Responsibility and Student Welfare Committee (SRSWC) have held their respective mentorship programmes: The mentorship programme offered by the SBC Academic Committee is dubbed as the "Academic Mentorship" and consists of a personalised mentorship programme, where one of the main criteria for mentor-mentee allocation is linguistic criteria. It has been noted that some students face difficulties with understanding dense readings in English, especially in their first semester, and along with the TA System, the Academic Mentors are expected to help their respective mentees in their respective native language. In addition to this, the Academic Mentors are expected to guide their mentees through skills such as research and writing. Mentorship was provided in: Hindi, Marathi, Maithili, Bhojpuri, Nepali, Bengali, Mewari, Marwari, Tamil, Kannada, Telugu, Punjabi, Urdu, Awadhi, Persian, Konkani, Haryanvi, Gujarati and Malayalam. The University has assisted in this programme, by providing Language Building Classes for those who have approached the Committee for linguistic help. The mentorship offered by the SRSWC gives a choice for the first years to put in their preferences for their mentors, and the mentors are expected to guide the freshers through their first year of college, providing support in social interactions, exploring campus and other such activities. In addition to these programmes, the University and the Moot Court Committee (MCC) also have a "Moot Mentorship Programme" for the first years, wherein the first year students are expected to attend classes taken by some of the University's top performers in Moot Court Competitions from the fourth and the fifth years - and

this 2 credit course ends in an evaluation which is done of the first years students through the “Introductory Moot”, where all the students are mandated to participate in this moot, and they are tested on the skills imparted during the mentorship. Research, Citations and Oral Arguments are the focus points in this mentorship programme. The Debating Society, and the Alternative Dispute Resolution Committee also conduct regular introductory debates and ADR, to acquaint the first year students with such competitions.

4.4.2 – Procedures and policies for maintaining and utilizing physical, academic and support facilities - laboratory, library, sports complex, computers, classrooms etc. (maximum 500 words) (information to be available in institutional Website, provide link)

Every incoming batch is given an orientation by not only the administration of the University, but is also acquainted to the rules and regulations by the Student Academic Committee. In addition to this, several mentorship programmes have been initiated to foster a conducive environment for the freshers. Sports facilities are available both inside the hostel compounds as well as common areas. There are gyms located in both the boys' and girls' hostels. The NALSAR Stadium is used for football and cricket. In addition to this, the University maintains basketball, volleyball, tennis, badminton, throwball and Kabaddi Courts for the benefit of the students. The students are represented in decision making through the Sports Committee. For using the physical facilities such as classrooms and conference halls, a permission is sought from the authorities, upon whose approval, the in-charge staff member will book the venue. The availability of the requested room is to be sought before asking for permission. University, during the pandemic has relied on two platforms for "virtual classrooms". The first is our meeting software which is powered by Cisco WebEx, and the second is "NALSAR Forums" which is an entirely student-built and in-house product which was developed specifically to provide recordings of classes to the students, to help those with limited internet access. University has embarked on a journey to upgrade the resources in the library, especially the electronic databases and journals, and has spent 6.5 crores for the same in two years. It started in March 2020, with the launch of the new "e-library" website, which helps navigation of all the resources. It also includes a page of compiled Open Access Resources to guide students during their research, with a special section dedicated to those blogs and journal which NALSAR students are associated with. The library OPAC has been upgraded to the cloud, to enable faster results and stable access. OPAC now includes the recently added e-books and physical copies of books. The e-library now enlists 174503 e-Resources and 28 digital database e-journals, such as JSTOR, Oxford

Handbooks Online, Oxford Scholarship Online, Cambridge e-books, The Ken, Edzter, Kluwer Arbitration, Bar and Bench, LiveLaw, IndiaStat CaseMine, SCC Online and Manupatra. NALSAR e-Library also provides access to most of the resources even when not on campus IP through a proxy server service - EzProxy. Library is also setting up a special section to the visually impaired students. The efforts for this include the repair and upgradation of the existing Braille Machine. In addition to this, several hardware and software has been procured, which includes JAWS Talking Screen Reader for the Blind, OpenBook Scanning and Reading Software with Peral Hi-Speed Camera, and Angel India Online Daisy Player. To bring the content in our e-resources under one roof, the Library is working on integrating our databases under one search engine, which is powered by FedGate, through what is known as the "Federation Search", and this currently covers 16 of our e-databases. We are working on adding more databases to this consolidation exercise.

The SBC is constituted to • Promote a cordial and harmonious relationship between the faculty, administration and student body • Create an avenue for the peaceful settlement of disputes and grievances thereof • Co-ordinate activities to stimulate intellectual, physical and moral development • Ensure social and individual liberty and equality amongst the student community vis-a-vis the faculty and administration and • Foster the spirit of a diverse and unprejudiced student community, Students are members of various committees of the University formed for organising seminars, conferences, workshops as well as the University convocation. Student representation is also there in the IT Committee, Internal Complaints Committee, IQAC, Anti-Ragging Committee, Editorial Board, Grievance Redressal Committee for the SBC Election etc. During the unprecedented period of the COVID-19 semester Jan-April 2020 the Various Committees of the SBC played crucial roles in smooth conduct of the left out semester classes and the examinations. The Academic Committee of the SBC worked out of its skin during the pandemic by creating an online platform " FORUMS" to share all class recordings and reading materials at one digital space. The various activities undertaken by the Committees of the SBC during the year under report: • The Academic Committee assisted the Library Committee to purchase books and e-resources. • ADR Committee organised numerous open challenges for domestic and international competitions - ICC Paris, 2020, CDRC Vienna Mediation Competition, 2020, INADR, Toronto Mediation Competition, YIMC Lisbon, Portugal 2020. • Sports Committee improved the sports infrastructure and increased sports culture on campus by organizing an inter-batch volleyball, cricket, chess and open badminton tournament on campus where around 70 teams participated. Inter college Volleyball and Basketball matches were organised in July-Oct, 2019. 1. All the decisions on the academic matters at the University are taken in consultation with the students and it is ensured that there is broad consensus between the students and faculty members. Even Academic Regulations are drafted in consultation with them. Draft Regulations are circulated to the students and their feedback is incorporated while finalizing the Regulations. Students were nominated as members by the Vice-Chancellor to the Committees which recommended the evaluation pattern for the semesters during the COVID-19 period and they were also invited for the first time in NALSAR's history as Special Invitees to the meeting of the Academic Council. During the COVID-19 period, the Students and Faculty Members had number of meetings and evolved the methodology for the conduct of the online classes and examinations and the evaluation pattern. The NALSAR Forums developed by the students with the support of the IT Team is one platform where discussions between the faculty members and students take place 24 x7 on academic and other matters. Open House Meetings with an invite to all the students are conducted on regular basis and formal feedback is taken from the students at the end of each semester for all the courses taught during the semester. Student's feedback on teaching plays an important role in the renewal of contracts of the teachers. 2. Students are part of the Committees where the decisions with regard to procurement of library and IT resources are involved. In fact, the e-resources for the Library to the extent of Rs. 3.43 Crores were procured with full involvement of the students in the whole process. Mess Tenders process is completely managed by the students themselves. President of Student Bar Council is involved in opening the tenders for the buildings. The fee concession by way of COVID-19 Financial Assistance was also provided to the students after detailed discussions with the student body.

**7.2 – Best Practices**

7.2.1 – Describe at least two institutional best practices

Title of the Practice: The NALSAR Forums • Objective of the Practice: The objective of the creation of the website NALSAR Forums (<https://nalsar.ac.in/forums/>), which is an online discussion board is to supplement learning by facilitating discussion between the peer groups and with the teacher and to serve as a repository for course material and recorded lectures. • Context: The sudden onslaught of COVID-19 pandemic coupled with Lockdown of the University led to suspension of classes from March 16, 2020 in the middle of the semester. With collective efforts from the students, teachers and staff within a span of 3 days University could shift to online mode of Teaching. University extended all possible help to support online classes by creating a virtual library by purchasing e-Books and e-resources for remote access, loaning the laptops, upgrading the data packs of the students and faculty, recordings of the classes were made available on class groups, pen drives carrying the recordings of the classes of the week were sent to all students who were unable to watch and listen in all the classes. NALSAR Forums is the brainchild of the SBC Academic Committee of 2019-20 and has been completely built in-house, and is built on the Wordpress platform and hosted on NALSAR's servers. The platform is in an attempt to make up for the lack of physical interaction due to the online mode of education by bridging the gap between teachers and students, both in terms of communications and discussion The practice: Forums has various features, such as multiple file uploading, threaded replies, private messaging, user notifications, email communications to help realise its objectives Forums has also been used by Committees for discussions with students surrounding policy consultations which were hosted by the Committees. NALSAR Forums is a crucial components of NALSAR's Online

Education during the pandemic. It ensured that the academic program was conducted in a harmonious manner with both the faculty and the students undertaking their tasks in awareness of the larger picture. Every part knew its place in the whole. It is expected that this online platform of communication which overcomes the limitations of time and space will continue to drive the University's academic communication even after the pandemic.

- Evidence of Success: Forums currently has 998 registered users, and more than 7270 media files, which includes classes, course materials as well as discussions on topics as diverse as philosophy and Maggi recipes. Flexibility without compromising on the learning experience informed its design. It ensures that everyone has the opportunity to come up to speed and no one is left behind. Both students and faculty rely upon the Forums to keep in touch is the biggest indicator of its success.
- Problems encountered: The largeness of the enterprise and the limited time within which had to be up and running were the greatest impediments faced by the program.

Second Best Practice

- Title of the Practice: DEVISE- Developing Inclusive Education
- Objective of the Practice: To work towards developing an inclusive education system by equipping the underprivileged children with functional understanding of English with a mission that they have equal access to opportunities in higher education and professions/careers. . To equip the children with basic understanding of their rights and duties.
- Context: While pursuing law at National Academy of Legal Studies And Research (NALSAR) University of Law, P Avinash Reddy and Ananye Krishna started conducting teaching sessions every weekend at an orphanage in Shamripet, Telangana. It was during these sessions that they realized that the children, all of whom attended the nearby Zilla Parishad High School, did not even have a basic understanding of English even though most of them were studying in 7th grade and above. Lack of basic understanding of English language hinders the children from accessing numerous opportunities in higher education and careers and in order to address this language barrier, they decided to conduct teaching sessions, specifically to improve their understanding of English.
- The practice: DEVISE has 110 volunteers who take turns to conduct English training sessions for the underprivileged children on a regular basis in the villages near Shamirpet. Understanding the importance of helping the children in developing a reading habit, the group established a 'Reading Room' at Zilla Parishad High School, Pudur with around 700 bilingual books (Telugu and English). It also established a Community base for Education (CuBE) in Muneerabad where the volunteers conduct English training sessions regularly after school hours.
- Evidence of Success: Nearly 100 children are benefiting from these activities. DEVISE team was the finalist HSF COMMUNITY ENGAGEMENT AWARD 2019 and received a certificate from Herbert Smith Freehills in recognition of their work related to inclusive education. VIDHI Centre for Legal Policy, has collaborated with DEVISE to provide internships to the Team Heads. The Vidhi Centre for Legal Policy is an independent think-tank doing legal research to make better laws and improve governance for the public good.

DEVISE has collaborated with Enhelion in order to strive for inclusive education for all by rewarding the best performing volunteers for their efforts. Enhelion , with its focus on bridging the gap between academia and the profession, is currently offering more than 300 courses which can be pursued by both law students and enthusiasts alike. Enhelion's courses and diplomas are developed in collaboration with renowned law firms and experts in the respective fields. These courses relate to a wide variety of fields including IP, Maritime law, Criminal law, Sports law, Aviation law, Tech law, Contract drafting etc.

- Problems encountered and resources required: Despite the initial difficulties in administering these sessions, the team is relentlessly working with the objective of addressing the English language barrier faced by the underprivileged children. As long as the underprivileged children are denied access to quality education, by the public education system itself, they will be excluded from accessing various opportunities. The team work, in the

form of various activities, strives to ensure that the higher education system and the subsequent professions become inclusive of children from the underprivileged backgrounds.

### 7.3 – Institutional Distinctiveness

7.3.1 – Provide the details of the performance of the institution in one area distinctive to its vision, priority and thrust in not more than 500 words

NALSAR Litigation Advocacy Project NALSAR Litigation Advocacy Project (NLAP) is a student run initiative, founded by Dayaar Singla, Bhavish Kaki and Vishal Rakhecha working for increasing legal aid and advocating for various social causes since September, 2018. The project has grown to over 10 students and receives guidance from Prof. (Dr.) Faizan Mustafa, Vice-Chancellor, NALSAR in his capacity as the Director of the Project. NLAP assists lawyers with pro bono or public interest litigation by providing assistance in terms of researching and drafting. NLAPs Public Policy vertical works towards creating change through measures that do not involve the judicial arm of the government. NLAPs Litigation vertical has closely worked with lawyers including Mr. Aman Wadud, in Assam on various cases which deal with the arbitrary decisions of the Foreigners Tribunal, pertaining to the citizenship issue. In collaboration with the well known multinational non-profit iProbono, India run by NALSAR alumni Ms. Swathi Sukumar it released a Foreigners Tribunal Lawyers Training Module. It is also working with Hyderabad based lawyers on matters of privacy, Aadhar and surveillance. The Policy vertical, had the honour to be invited to testify before the US Trade Representative (USTR) on the Special 301 Report in Washington D.C. where the Project argued for a better status for India and removal of our country from the Priority Watch List. NLAP also worked on a report with the renowned US based non-profit Avaaz on the issue of fake news and misinformation. The Project has also worked with Save Life Foundation and assisted in research and legal drafting for proposed amendments to the Central Motor Vehicles Rules, 1989. Further, NLAP worked with Legal Initiative for Forest and Environment (LIFE) on creating a database of cases on Biological Diversity Act, 2002 and in preparation of a report on the status of its implementation with special focus on South India. At NALSAR, we also held a documentary screening for 'Between Hatred and Fear: Surviving Detention in Assam', and held a discussion with Leah Verghese, (NLSIU, Columbia). NLAP is NALSARs another step towards furthering the Universitys objectives.

University proposes to provide financial support to the Faculty members to undertake minor / major research projects. • Financial Support to Research Centres: For the activities of the Research Centres, University has provided an amount of Rs. 30 lakhs in its budget. The Centres are requested to organize conference, seminars, workshops, bring out publications etc. FACULTY INCENTIVE SCHEMES • Faculty Exchange Programme: To encourage faculty members to take up assignments / undertake research in reputed Foreign Universities, the University has provided an amount of Rs. 10 lakhs to provide financial assistance for the faculty members under the Faculty Exchange Programme. • Monetary and academic incentives for quality publications: To encourage Faculty Members to bring out quality publications monetary and academic incentives are provided.
