### 16. Multidisciplinary / interdisciplinary

NALSAR offers full time taught programmes in law and management. Both areas include courses which have an interdisciplinary character. For example, in the 5-Year Integrated B.A., LL.B.(Hons.) Programme students are required to complete 200 credits out of which at least 44 credits have to be earned through social sciences courses such as those in English, Political Science, History, Sociology and Economics. Apart from these social science courses law students can also choose elective and seminar courses which have an interdisciplinary approach. In the 2-Year MBA programme, management students also take courses in law and the humanities apart from their required courses in commerce and business management. Our Ph.D. programmes also invites applications from candidates interested in pursuing research in Law, Management, Social Sciences & Humanities. Hence, we have tried to inculcate an interdisciplinary approach in the delivery of these professional courses.

### 17. Academic bank of credits (ABC):

Since A.Y. 2012-13, NALSAR has developed a choice based credit system (CBCS) in its taught programmes. For example in the 5-Year Integrated B.A., LL.B. (Hons.) students complete 36% of their coursework through electives and seminars. In the LLM programme, students complete 60% of their coursework through electives, seminars and a dissertation. In the 2-year MBA programme students can complete 40% of their coursework through electives. This is possible due to CBCS where differential weightage is given to each course based on the number of classroom hours. This implies that for law students a 1 credit course will carry 16 hours, 2 credits imply 32 hours, 3 credits imply 48 hours, 4 credits imply 64 hours and 5 credits imply 80 hours. Students are also allowed to enrol in several visiting elective courses. Since we already have a CBCS in

place, we can easily join the academic bank of credits (ABC) proposed by National Education Policy (NEP), 2020. We can integrate our courses into a bank of credits, where students who have to discontinue their studies can return to the higher education system. Based on collaborations with other universities, provision can also be made for credits to be transferred to other universities.

#### **18.Skill development:**

All of our full time taught programmes, research degrees and distance education programmes place a strong emphasis on the development of skills needed for academic and professional excellence. For example law students undertake courses such as Moot Court Clinic, Alternate Dispute Resolution (ADR) methods and subject wise clinical courses to develop their skills for research, drafting and advocacy. Even in the mandatory courses students are required to write assignments such as book reviews, interviews, newspaper analysis, case comments, and research papers thereby developing their capacity for independent research and analysis. Management students are required to complete assignments based on group discussions, case studies, structured presentations and business simulations. Experts from other universities, industry and professionals are regularly invited to speak to our students about the practical dimensions of their respective area of study. NALSAR places a special emphasis on the development of social and communication skills by encouraging students to participate in as well as organise range of co-curricular activities such as moot courts, ADR competitions, competitive debates, essay writing, sports and cultural activities.

#### **19.Appropriate integration of Indian Knowledge system (teaching in Indian Language, culture, using online course)**

Even though we are offering professional programmes, we are deeply invested in delivering education that is relevant to the context of south Asia. Hence, most of our social science courses such as history, political science and sociology are taught in such a manner that students develop



a good understanding of intellectual traditions from Indian history. Several specialised elective and seminar courses showcase the significance of our heritage and culture, especially by encouraging students to produce research papers based on the same. Due weightage is given to sources produced in the respective Indian languages and the students are encouraged to work with translated texts and their interpretations. To give specific examples we have social science seminars in areas such as 'Democracy and Decentralisation' (which examines the working of the panchayati raj system), 'Ideology and Cultural Context of Colonial India' (which examines the connections between indigenous and foreign intellectual traditions), 'Religion and Secularism' (which examines the complex relations between law and religion in south asian societies), and 'Language Politics' (which examines the tensions between English and Indian languages in public activities such as education, employment and political representation).

**20.Focus on Outcome based education (OBE):Focus on Outcome based education (OBE):**

Since we are offering professional courses, research degrees and distance education programmes, the outcomes of each category are slightly different. In the full time taught programmes the main outcomes are to prepare our graduates to demonstrate professional excellence, social sensitivity and ethics in their careers. Hence our courses emphasise theoretical knowledge as well as its application to concrete practical problems. This is why we deliver a mixture of mandatory and elective courses spanning a broad range of subjects. In our research degrees our aim is that the scholars enrolled with us will produce original scholarship that advances the state of knowledge in their chosen area. This involves both descriptive and normative inquiry into the working of political, social and economic institutions. Our distance education programmes are aimed at working professionals who are looking to gain specialised knowledge in the respective areas covered by the various degrees and diplomas. The orientation of the distance education programmes is more to disseminate

knowledge amongst a larger audience, and to that extent their purpose and outcomes are very different from our full-time taught programmes and research degrees.

#### **21.Distance education/online education:**

The Directorate of Distance Education offers Two Year M.A. and One Year Advanced Diploma Programmes in several areas that have practical relevance. The M.A. Programmes are offered in Aviation Law & Air Transport Management; Security & Defence Laws; Space & Telecommunication Laws; Maritime Laws; Criminal Law & Forensic Science; International Taxation and Animal Protection Laws. One Year Advanced Diploma Programmes are offered in Patents Law; Media Laws; Cyber Laws; International Humanitarian Law; Animal Protection Laws; Alternative Dispute Resolution; Family Dispute Resolution; Drafting, Negotiation & Enforcement of Contracts; Aviation Law & Air Transport Management; Maritime Laws; Criminal Law & Forensic Science; Financial Services & Legislations; GIS & Remote Sensing Laws; Corporate Taxation and Cyber Security & Data Protection Laws.

These courses are transacted through periodic contact classes with examinations held at the end of the academic year or the corresponding semester. Graduates of any discipline are eligible to apply. There is a provision for Lateral Admission in the Second Year M.A. Programme and also option to Exit from the M.A. Programme after the First Year subject to fulfillment of the eligibility and other conditions as specified in the Regulations.

The robust Choice Based Credit System at NALAR affords opportunity to develop curricula and offer courses in keeping with current legal and societal issues. Consequently, courses on offer were ranging from those capturing international developments, such as Investment Treaty Law, International Commercial Arbitration, Consumer Justice in the Era of Globalisation, to those examining issues closer home, for instance Language Rights and Access to Health (for Indigenous/Tribal Communities), Caste and Political Mobilization in India. With the onslaught of an unprecedented pandemic systemically impacting existing arrangements and legal order, it was a felt need to offer courses that get students to appreciate legal implications of the pandemic. Courses such as Commercial Remedies in times of Covid, Covidization & Contemporary International Law offered such insights.

The curricula is consistent with the University's mandate of producing technically sound and socially relevant lawyers.

The furtherance of its goals of attaining social justice through legal education, the University has been mindful of integrating crosscutting issues of ethics, gender, human values in its courses. While one level of integration and critical thinking is routed through mandatory courses such as Legal Methods and Professional Ethics, the other level of engagement is attained through elective courses that requires close questioning and critical reflection. Courses as Legal Personhood; Madness, Disability and the Normal, Ethnographies of Labour and Comparative Political Equality.

In addition to the mandatory course on Environmental Law, courses such as Environmental Justice: Stories & Struggles, Agricultural Policy & Sustainable Development makes for a continuous engagement with issues of contemporary times. The University also offer a one-of its-kind clinic course on Animal Protection Laws and Policy.

## 2.2 - Catering to Student Diversity

2.2.1 - The institution assesses the learning levels of the students and organises special Programmes for advanced learners and slow learners

The University, along with the Student Bar Council, has come up with multiple mentorship programmes, which help students, especially Fresher Batches, cope with the Academic and other such challenges. The University allows students to learn at their pace and therefore they can opt for more credit courses or less credit courses. The Freshers are each allocated a mentor, which takes into consideration the needs of the student, which includes linguistic preferences, to enable the student to be mentored in a language which they are comfortable in. In addition to this, the mentorship programme also covers other aspects in areas such as Academic Writing and Approaching Internships. These programmes, which are organised in coordination with Faculty and Alumni are available to students of all batches, and would enable them to either enhance their already existing skill-set, or to start at a beginner level to learn the basics of the same.

### 2.3 - Teaching- Learning Process

2.3.1 - Student centric methods, such as experiential learning, participative learning and problem-solving methodologies are used for enhancing learning experiences

The University has undertaken efforts to enhance the learning experiences of students. One such initiative is the Tutorial System which is followed. The system is integrated into the Academic Regulations of NALSAR, where 12 out of the mandatory number of classes in the first, second and third years are taught by the senior-most batch of the students. The advantage of this system is that students are divided into smaller groups of 12-15 students, which enables more engaging conversations, and less fear of judgement while asking questions. The tutors are also evaluated on their performance. Seminar Courses are courses which take no more than 20 students, whose focus is on paper submission and class discussions. There exists individual attention and guidance to complete the papers, whose topics are chosen to tackle the current-day problems and challenges.

The University has used the help of Turnitin (Anti-Plagiatism Software) in both the submission of projects as well as submission of answer scripts of mid-semester and end-semester assessments during the online semesters. Every student is given a NALSAR Email ID powered Turnitin account, and every student gets a list of submissions which are scheduled for the particular semesters, along with the deadline for the same, in the same portal. The use of the portal has streamlined the Examination Department's management and conduct of evaluation. The use of the Anti-Plagiarism Software has improved the academic integrity of the works of students, as well as curbed academic malpractices in the examinations.

University believes in democratic collegial self-governance. Its administration is decentralized and adopts bottom up approach in

decision making. Faculty, students and non-teaching staff are involved in various committees whose decisions are executed by the university functionaries. Full autonomy is given to the departments to take decisions. Delegation of power and decentralised decision making are our mantra in governance. Various Committees, like, Academic & Examination Committee, P.G. Committee and Research Committee are constituted which suggest the curriculum reforms, conduct training for the tutors, to invite the experts for offering of courses, conducting the examinations etc. These Committees function independently implementing the Regulations framed by the University Bodies. In the day to day activities, if any major decision is to be taken, the Committee after detailed deliberations submits its recommendations to the Vice-Chancellor, who will take a decision depending on the circumstances and the facts.

Vice-Chancellor also holds regular meetings with the members of the Student Bar Council to take their inputs before taking major decisions involving students. SBC Academic Committee - Acts as a bridge between the students and the University Academic Committee and the Examination Committee. Also assists in Library administration in procurements of books and e-resources.

## 6.2 - Strategy Development and Deployment

### 6.2.1 - The institutional Strategic plan is effectively deployed

University always emphasized on creating strong conceptual foundation of every subject so that students can appreciate the interplay of law with societal and economic forces. With online learning progressively seen as being the new normal, it was realized that online teaching and learning required devising different techniques to transact more effectively. Teachers worked towards making the sessions interactive. Breakout -rooms were used to allow facilitating group discussions. With continuing online semesters, it was imperative to provide access to softcopies of books and reading materials both to students as well as faculties. NALSAR Library has upgraded its e-book collection and subscribed to new data-bases and established itself as one of the best e-library among National Law Schools with 50,186 Print Books; 6,315 (perpetual) & 2,10,601 (Annual subscription) e-books; 84 Print Journals; 17 e-Journals; 19 e-Databases. NASLAR Forums was created as responsive and augmentative reality platform that serves as repository of classes



and facilitates discussions. It has 9,441 files with 1,011 users. Around 412 forums were created with a total of 8,851 responses on 1,623 topics. NALSAR was able to complete its academic sessions without any loss of course coverage with its strategic plan that was deployed in consultation with all stakeholders.

6.5.1 - Internal Quality Assurance Cell (IQAC) has contributed significantly for institutionalizing the quality assurance strategies and processes by constantly reviewing the teaching learning process, structures & methodologies of operations and learning outcomes at periodic intervals

University had to adopt online teaching methodology due to covid in June 2020. IQAC asked the teachers to record their lectures as it was possible in online teaching and it could be made available to

the students who miss their classes due to covid. The recording of classes has brought some requisite rigour to the lectures. The informal recording of lectures was allowed on day-to-day basis even now also; whenever any student is infected, he/she can follow the classes through recording and it has sorted out all the problems of students who were not able to attend to the classes for any genuine health reason. Even for late admissions recorded lectures are helpful to bridge the gap. IQAC required the teachers to share their course instead of sections as all students can login to the same class as it was online. Faculty of both the sections were required to login and conduct the class together, this has brought the co-teaching initiative really to the forefront. This has changed coteaching from being mere sharing classes, materials and conducting examination to sharing subject expertise. This created a peer learning teaching environment for each course.

and competitive. NALSAR You tube channel has uploaded many videos for furthering the learning opportunities. Online library resources were asked to be increased substantially to ensure continuance of learning momentum for the students from their home. IQAC also recommended to study the feasibility of converting the existing classrooms to smart class rooms to be able to encounter any future contingency and be able to cater to diverse needs such as hybrid model. The clinical courses had the most tough time during online semesters as they were not the taught courses, however lectures on some of the basic aspects also was found useful for the students and it also met the regulatory requirement. The lectures on those topics were retained as part of the course in addition to the clinical course requirement.

The waste water from student hostels, toilets, canteen, dining hall, buildings, faculty rooms, faculty/ staff quarters, offices, etc. is stored in an underground sump of 1.00 Lakh Litre capacity. The waste water from the sump is pumped to the STP (MBBR technology) of 150 kLPD capacity. The treated water is pumped by a 3 H pump to a 30KL storage tank and used for watering the plantations, gardening, etc. The sludge generated is dried and disposed. The STP plant comprises four numbers of blowers (10HP) and two numbers of monoblock pumps (3HP). The STP is taken for maintenance & cleaning every three months. The Bio-medical Waste is segregated under 4 categories (Yellow, Red, White, Blue). Under Yellow category Human/Animal anatomical Waste, Placenta, Plaster Case, Contaminated Cotton Swabs, Contaminated Dressing, etc., Under Red category Syringes, Gloves, Blood Bag, Urine Bag etc., Under White category Needles, Blades etc., Under Blue category Ampoules, Cials, Lab Sliders, Scissors

etc., are collected and all these wastes are handed over to GJ Multiclave (India) Pvt. Ltd., Which provides Bio-medical waste management services in Hyderabad.

The University has undertaken efforts to enhance the learning experiences of students. One such initiative is the Tutorial System which is followed. The system is integrated into the Academic Regulations of NALSAR, where 12 out of the mandatory number of classes in the first, second and third years are taught by the senior-most batch of the students. The advantage of this system is that students are divided into smaller groups of 12-15 students, which enables more engaging conversations, and less fear of judgement while asking questions. The tutors are also evaluated on their performance. Seminar Courses are courses which take no more than 20 students, whose focus is on paper submission and class discussions. There exists individual attention and guidance to complete the papers, whose topics are chosen to tackle the current-day problems and challenges.

University believes in democratic collegial self-governance. Its administration is decentralized and adopts bottom up approach in decision making. Faculty, students and non-teaching staff are involved in various committees whose decisions are executed by the university functionaries. Full autonomy is given to the departments to take decisions. ## 6.2.1 - The institutional Strategic plan is effectively deployed

University always emphasized on creating strong conceptual foundation of every subject so that students can appreciate the interplay of law with societal and economic forces. With online learning progressively seen as being the new normal, it was realized that online teaching and learning required devising different techniques to transact more effectively. Teachers worked towards making the sessions interactive. Breakout -rooms were used to allow facilitating group discussions. With continuing online semesters, it was imperative to provide access to softcopies of books and reading materials both to students as well as faculties. NALSAR Library has upgraded its e-book collection and subscribed to new data-bases and established itself as one of the best e-library among National Law Schools with 50,186 Print Books; 6,315 (perpetual) & 2,10,601 (Annual subscription) e-books; 84 Print Journals; 17 e-Journals; 19 e-Databases. NASLAR Forums was created as responsive and augmentative reality platform that serves as repository of classes and facilitates discussions. It has 9,441 files with 1,011 users. Around 412 forums were created with a total of 8,851 responses on 1,623 topics. NALSAR was able to complete its academic sessions without any loss of course coverage with its strategic plan that was deployed in consultation with all stakeholders.

## 6.5 - Internal Quality Assurance System

6.5.1 - Internal Quality Assurance Cell (IQAC) has contributed significantly for institutionalizing the quality assurance strategies and processes by constantly reviewing the teaching learning process, structures & methodologies of operations and learning outcomes at periodic intervals

University had to adopt online teaching methodology due to covid in June 2020. IQAC asked the teachers to record their lectures as it was possible in online teaching and it could be made available to the students who miss their classes due to covid. The recording of classes has brought some requisite rigour to the lectures. The informal recording of lectures was allowed on day-to-day basis even now also; whenever any student is infected, he/she can follow the classes through recording and it has sorted out all the problems of students who were not able to attend to the classes for any genuine health reason. Even for late admissions recorded lectures are helpful to bridge the gap. IQAC required the teachers to share their course instead of sections as all students can login to the same class as it was online. Faculty of both the sections were required to login and conduct the class together, this has brought the co-teaching initiative really to the forefront. This has changed coteaching from being mere sharing classes, materials and conducting examination to sharing subject expertise. This created a peer learning teaching environment for each course.

6.5.3 - Incremental improvements made for the preceding during the year with regard to quality (in case of first cycle) Post accreditation quality initiatives(second and subsequent cycles)

IQAC recommended that the University should discontinue the distinction between part time and full time Ph.D. This was necessitated to bring in more rigour to the Ph.D. program. IQAC recommended to start an Integrated Program in Management (IPM) to make the management education more comprehensive, interdisciplinary and competitive. NALSAR You tube channel has uploaded many videos for furthering the learning opportunities. Online library resources were asked to be increased substantially to ensure continuance of learning momentum for the students from their home. IQAC also recommended to study the feasibility of converting the existing classrooms to smart class rooms to be able to encounter any future contingency and be able to cater to diverse needs such as hybrid model. The clinical courses had the most tough time during online semesters as they were not the taught courses, however lectures on some of the basic aspects also was found useful for the students and it also met the regulatory requirement. The lectures on those topics were retained as part of the course in addition to the clinical course requirement.

The waste water from student hostels, toilets, canteen, dining hall, buildings, faculty rooms, faculty/ staff quarters, offices, etc. is stored in an underground sump of 1.00 Lakh Litre capacity. The waste water from the sump is pumped to the STP (MBBR technology) of 150 kLPD capacity. The treated water is pumped by a 3 H pump to a 30KL storage tank and used for watering the plantations, gardening, etc. The sludge generated is dried and disposed. The STP plant comprises four numbers of blowers (10HP) and two numbers of monoblock pumps (3HP). The STP is taken for maintenance & cleaning every three months. The Bio-medical Waste is segregated under 4 categories (Yellow, Red, White, Blue). Under Yellow category Human/Animal anatomical Waste, Placenta, Plaster Case, Contaminated Cotton Swabs, Contaminated Dressing, etc., Under Red category Syringes, Gloves, Blood Bag, Urine Bag etc., Under White category Needles, Blades etc., Under Blue category Ampoules, Cials, Lab Sliders, Scissors etc., are collected and all these wastes are handed over to GJ Multiclave (India) Pvt. Ltd., Which provides Bio-medical waste management services in Hyderabad.

## 7.2 - Best Practices

7.2.1 - Describe one best practice successfully implemented by the Institution as per NAAC format provided in the Manual

### 1. Title of the Practice : Visiting Elective Courses

2. Objectives of the Practice: To ensure that students learn from external scholars and practitioners, especially in areas where our faculty expertise is limited.

3. The Context: To ensure diversity in the courses that are offered, we regularly invite suggestions from faculty and students. Accordingly, we invite the external scholars and practitioners, both from India and Abroad.

4. The Practice: The intent has been to equip our students with interdisciplinary knowledge and skills that go beyond the mandatory subjects. Courses are offered in Social Sciences, Humanities and Business studies apart from Law. The challenge is to attract fresh resource persons every semester and to keep up with the latest developments.

### 5. Evidence of Success

Since, A.Y. 2012-13 we have offered 25-30 visiting elective courses in each academic year, which is the highest amongst the NLU's. This has enabled better employment outcomes for our graduates and higher admission rates in foreign universities.

### 6. Problems Encountered and Resources Required

Attracting foreign resource persons requires substantial funding. In some cases, we did this through the GIAN programme. However, we will need more financial support to attract foreign resource persons.

## 7.3 - Institutional Distinctiveness

- NALSAR established a Centre for Disability Studies in 2006. The faculty and students associated with this centre assisted in the drafting of the UN Convention on the Rights of Persons with Disabilities. The Centre regularly organizes training programmes and workshops to develop research capacities in this field.
