1) Junior Assistant (Accounts)

- Additional preference would be given to candidates with fluency in English both written and oral.

2) Junior Assistant

Graduate in any subject from a reputed University having adequate knowledge in computer applications. The candidate should be fully conversant with MS Word, MS Excel, MS Powerpoint, etc.

- Preference would be given to Graduates with 1st class Degree and having fluency in English language both written and oral.
- Additional preference would be given to candidates having good typewriting skills in English.
- Preference would be given to candidates having a minimum of two years of relevant work experience.

GENERAL INFORMATION:

1. The prescribed qualifications and experience are minimum and the mere fact that a candidate possesses the same will not entitle him / her for being called for interview. The University reserves the right to restrict the candidates to be called for interview to a reasonable number on the basis of qualifications and experience higher than the minimum prescribed; or by any other condition that it may deem fit. Those who are possessing higher qualifications will be given preference in short-listing the candidates. The University may constitute a Screening Committee to scrutinize the applications and short-list the candidates. Call letters for test / interview will be sent only to the short-listed candidates and no correspondence will be made with applicants who are not short-listed.
2. Everything being equal, preference would be given to females and younger candidates.
3. It would be open to the University to consider the names of suitable persons who may not have applied, but recommended by experts in their respective fields.
4. The University will have the right to relax any of the qualifications, experience etc.
5. University reserves the right to fill or not to fill any of the above positions. The University may consider one or more positions against notified posts depending on the requirement of the University.
6. Canvassing in any form on behalf of any candidate will disqualify such a candidate.
7. The Selection Committee may decide its own method of evaluating the performance of the candidates in interview. The University may utilize written test / skill test as method of selection.
8. Incomplete applications in any respect shall not be considered at all.
9. No interim queries regarding test / interview / selection will be entertained.
10. University will not be responsible for any postal delay at any stage.
11. In case of any disputes / suits or legal proceedings against the University, the Jurisdiction shall be restricted to the Courts in Hyderabad, which is the Headquarters of the University.
