**RECRUITMENT DATA | BATCH OF 2019**

The Recruitment Coordination Committee 2019 [“RCC”] takes immense pride in announcing the successful culmination of the recruitment season for the Batch of 2019. The RCC achieved a record 100% recruitment, as has been the trend of NALSAR recruitment, by securing the placements of its 52 (fifty-two) subscribers at domestic and international law firms, various corporate houses and PSUs by the end of April 2019.

The RCC successfully catered to the varied career choices of the students and welcomed diverse organisations for conducting recruitment. We would like to express our gratitude towards the entities that share a longstanding relationship with us and continue to believe in the competence of the students of NALSAR. We further extend our gratitude to the entities that recruited students from our pool of subscribers for the first time this year and look forward to building a strong relationship with them in the future.
