If the candidate in the Selected List fails to make the payment and submit the documents before the schedule date and time, the offer of provisional admission will stand automatically cancelled and the offer will be given to the candidate in the Wait List.

Provisional admission will be offered to the Wait List candidate only if there are vacancies under the said category and they will be informed of the same on **August 25, 2021 (by 5.00 p.m.)**. If the wait listed candidate fail to make the payment before **August 26, 2021 (by 4:00 p.m.)**, his/her candidature will not be considered for admission, in case of any vacancy.

The admission will be subject to fulfillment of the eligibility and completion of admission formalities as per the schedule. The provisional admission will be offered based on the documents (scanned copies) submitted. In case any discrepancy is found on a later date and / or on physical verification of original documents, the provisional admission offered will stand automatically cancelled and the total fee paid by them will be forfeited.
